Photo ID Requirements

Beginning in 2016, Most voters will need to show acceptable Photo ID
at the Polls:

NC Drivers License/Permit (may be expired up to four (4) years)

NC Identification Card (may be expired up to four (4) years)

US Passport/Passport Card (unexpired)

Military Identification Card (unexpired, if there is an expiration date)

Veterans Identification Card (unexpired, if there is an expiration
date)

Certain Tribal Enrollment Cards (*cards issued by NC recognized
tribes and approved by the State Board of Elections are acceptable for
voting if they have an expiration date and are unexpired. Cards issued
by federally - recognized tribes are acceptable if they have an expira-
tion date and are unexpired, or if they have an issuance date and were
issued within eight years.)

Primary Rules:

Voters who are *affiliated* (registered with a political party) are only eligible to participate in their party's primary. Voters who are not affiliated (registered as *unaffiliated*) with a political party may vote in a party's primary or may choose a non-partisan ballot.

If you are unsure of your party affiliation or wish to change your affiliation, please contact the Board of Elections Office *BEFORE MAY 13, 2016*. Party changes for the June 7, 2016 Primary will not be allowed after May 13, 2016.

Sample Ballots:

Voters may obtain a sample ballot by visiting www.ncsbe.gov, clicking on Voter tools, then Voter lookup or going directly to:

https://vt.ncsbe.gov/Voter_Search_Public/default.aspx

The Voter will enter their name in the appropriate boxes then click the search button. If there is more than one person with the same name you must click on your name from the list. After you click on your name the Voter Details should appear. You may have to scroll down to see the Sample Ballot heading. Note, if you see a box with a plus sign, click on it to expand the information. If you have an eligible ballot for the current election there should be a ballot style/number assigned. Click on that number to get a copy of your sample ballot.

If you do not have internet access, you may contact the Elections Office and we will mail you a sample ballot.

Same Day Registration:

Same Day Registration will be permitted at One Stop Early Voting Site. Voters must present proper identification. For information on requirements contact the election office.
