



## Agreement for the use of Rowan County No-Till Drill

- Any citizen in Rowan or surrounding counties are eligible to use the no-till drill. To pull the drill it is recommended that a tractor have a minimum of 35hp, and required to have remote hydraulic hook-ups. The drill must be towed at a slow, safe speed.
- Scheduled use and pick-up of the drill will be through the Rowan County Soil and Water Conservation District office. The office is located at 2727 Old Concord. Rd., Salisbury, NC 28146. To schedule, contact [Chris.Sloop@rowancountync.gov](mailto:Chris.Sloop@rowancountync.gov) or call (704) 216-8999
- A \$50 deposit will be required at pick-up. This deposit will be applied to the payment once the drill is returned clean and in good condition.
- Rental rate is \$10/acre with a \$25 minimum.
- There will be a \$5 charge if the hitch pin is not returned with the drill.
- The renter is responsible for paying for all acres drilled. The drill may only be used by the renter during the rental period.
- The drill may be rented for a maximum of seven (7) calendar days. A \$25 late fee may be applied. However, adverse weather conditions will be considered. Please contact us if you need the drill longer than your rental period. Another person may be scheduled to rent the drill so please be considerate.
- Should the drill break down during your possession please CONTACT US PRIOR TO MAKING ANY REPAIRS! Chris Sloop 704-245-3847
- The drill should be returned clean and in working condition as received. Vacuum or blow out hoppers. WASH THE OUTSIDE OF THE DRILL IF EXCESSIVE MUD IS REMAINING. Report any damages or concerns at the time of return.
