**Important Reminders**

- **Filing fees** must be paid at the time of filing. Accepted forms: cash or check. (fee over \$50.00 must be a check)
- **Residency requirement:** Candidates must reside in **Rowan County** and in the district, they are filing for.
- **Party affiliation:** Candidates must be registered with a **North Carolina recognized political party** for at least 90 days before filing, per **GS 163-106.1**.

**Additional Reminders:**

\* These candidates must submit a **Statement of Economic Interest** with the North Carolina State Board of Elections

† Sheriff candidates must obtain a valid **Felony Disclosure Statement from the NC Sheriff's Training & Standards Division (NC G.S. 163-106(f))**
