

## Notice of Rowan County Election Day Precinct Buffer Zones

The following is a list of Rowan County early voting sites. All sites use a 50-foot radius from the entrance as the buffer zone. Buffer zones are set as designated by G.S. 163-166.4. Election officials will mark buffer zones with cones, “No Electioneering Beyond this Point” signs, and paint or tape.

Campaigners are not to enter the buffer zone. Campaigning issues or suspected violations are to be brought to the attention of the Chief Judge of the site and the Board of Elections office.

Campaigners must never block traffic, fire lanes, entrances, parking spaces or sidewalks. **Handicap parking spaces must never be blocked.** Campaigning supplies must not be left unattended and may not be left at the sites overnight. The Rowan County Board of Elections is not responsible for items left unattended.

### For the 2026 Primary Election, the following precincts will be open:

<b>Precinct #1 Barnhardt Mill</b>
<b>West Park Baptist Church, 715 W. Park Dr., Rockwell</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #2 Blackwelder Park</b>
<b>Blackwelder Park Baptist Church, 2204 Summit Ave., Kannapolis</b>
Buffer Zone: 50 ft. from side entrance; marked with cones, signs, and tape.
Campaigning area: <b>This polling place is RESTRICTED.</b> This means NO electioneering activities are permitted on their property. This includes distributing campaign literature, soliciting votes, displaying political advertising (campaign signs) or otherwise engaging in election related activity.
Signage: Not permitted on church property.

<b>Precinct #3 Bostian Crossroads</b>
<b>Bostian Heights Fire Dept., 8211 Old Concord Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, and signs.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #4 Bradshaw</b>
<b>Atwell Fire Dept., 135 Concordia Church Rd., China Grove</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #5A – China Grove</b>
<b>China Grove Community Building, 412 S. Myrtle Ave., China Grove</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #7 - Cleveland</b>
<b>Cleveland Town Hall, 302 E. Main St., Cleveland</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #8 – South Locke</b>
<b>Grace Lutheran Church, 3020 Grace Church Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: <b>This polling place is RESTRICTED</b> . This means NO electioneering activities are permitted on their property. This includes distributing campaign literature, soliciting votes, displaying political advertising (campaign signs) or otherwise engaging in election related activity.
Signage: Outside of 50' buffer zone.

<b>Precinct #9 – East Enochville</b>
<b>Enochville Fire Department, 808 N. Enochville Ave., China Grove</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #10 - Faith</b>
<b>Faith American Legion Building, 1015 Gantt St., Faith</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #11 - Franklin</b>
<b>Shoaf's Wagon Wheel, 151 Barn Dance Dr., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #12 – Milford Hills County</b>
<b>West Rowan Middle School, 5925 Statesville Blvd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #13 – Rock Grove</b>
<b>Rock Grove United Methodist Church, 1050 Rock Grove Ch. Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: This polling place is RESTRICTED. This means NO electioneering activities are permitted on their property. This includes distributing campaign literature, soliciting votes, displaying political advertising (campaign signs) or otherwise engaging in election related activity.
Signage: Not permitted on church property

<b>Precinct #14A – Granite Quarry</b>
<b>Granite Quarry Municipal Bldg., 143 N. Salisbury Ave., Granite Quarry</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #15 - Hatters Shop</b>
<b>Union Fire Department, 1470 Union Church Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #16 – West Kannapolis</b>
<b>St. John's Reformed Church, 901 N. Main St., Kannapolis</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: <b>This polling place is RESTRICTED.</b> This means NO electioneering activities are permitted on their property. This includes distributing campaign literature, soliciting votes, displaying political advertising (campaign signs) or otherwise engaging in election related activity.
Signage: Not permitted on church property.

<b>Precinct #17 – East Kannapolis</b>
<b>Jackson Park United Methodist Church -Hut Building Only – 1111 Jackson St., Kannapolis</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight. <b>Signs are only to be placed at the Hut Property and not across the road at the church.</b>
Signage: Outside of 50' buffer zone.

<b>Precinct #18 – East Spencer</b>
<b>East Spencer Municipal Building, 105 S. Long St. East Spencer</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #19A - Landis</b>
<b>Rowan Public Library – South Branch, 920 Kimball Rd., China Grove</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #21 – North Locke</b>
<b>Salem Lutheran Church, 5080 Sherrills Ford Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: <b>This polling place is RESTRICTED.</b> This means NO electioneering activities are permitted on their property. This includes distributing campaign literature, soliciting votes, displaying political advertising (campaign signs) or otherwise engaging in election related activity.
Signage: Not permitted on church property.

<b>Precinct #22 – Morgan I</b>
<b>Pooletown Fire Department, 255 Richfield Rd., Richfield</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #23 – Morgan II</b>
<b>West Liberty Fire Department, 135 St. Matthews Church Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #24 – Mt. Ulla</b>
<b>Mt. Ulla Station-West Rowan Fire Dept., 781 Grampian Rd., Mt. Ulla</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #25 - Rockwell</b>
<b>Rockwell American Legion Building, 8580 US Hwy 52, Rockwell</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #26 – Gold Knob</b>
<b>East Rowan High School, 175 St. Lukes Church Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #27 – Scotch Irish</b>
<b>Scotch Irish Fire Department, 3220 Needmore Rd., Woodleaf</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #28 - Spencer</b>
<b>Spencer Municipal Building, 460 S. Salisbury Ave., Spencer</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #29 - Steele</b>
<b>West Rowan High School, 8050 NC Hwy 801, Mt. Ulla</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #30 - Sumner</b>
<b>Rowan County Agricultural Bldg., 2727 Old Concord Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #31 – Trading Ford</b>
<b>Miller Ferry Fire Dept., 2650 Long Ferry Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #32 - Unity</b>
<b>Woodleaf Fire Department, 3500 NC Hwy 801, Woodleaf</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #33 – Bostian School</b>
<b>Bostian Elementary School, 4245 Old Beatty Ford Rd., China Grove</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #34 - West Ward II</b>
<b>Maupin Avenue Presbyterian Church, 100 Maupin Ave., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: <b>This polling place is RESTRICTED.</b> This means NO electioneering activities are permitted on their property. This includes distributing campaign literature, soliciting votes, displaying political advertising (campaign signs) or otherwise engaging in election related activity.
Signage: Not permitted on church property.



<b>Precinct #35 – West Ward I</b>
<b>Rowan Public Library – Main Branch, 201 W. Fisher St., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #36 – South Ward</b>
<b>Salisbury Civic Center, 315 S. Martin Luther King Jr. Ave., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #38 – East Ward</b>
<b>Park Avenue Community Center, 632 Park Ave., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #39 – West Innes</b>
<b>VFW Post #3006, 1200 Brenner Ave., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.

<b>Precinct #40 – North Ward</b>
<b>City Park Recreation Building, 316 Lake Dr., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50’ buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50’ buffer zone.



<b>Precinct #41 – Milford Hills City</b>
<b>Isenberg Elementary School, 2800 Jake Alexander Blvd. N., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #42 – West Ward III</b>
<b>Miller Recreation Teen Center, 1402 W. Bank St., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.

<b>Precinct #44 – West Enochville</b>
<b>Piedmont Baptist Church, 5870 Wright Rd., Kannapolis</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: This polling place is RESTRICTED. This means NO electioneering activities are permitted on their property. This includes distributing campaign literature, soliciting votes, displaying political advertising (campaign signs) or otherwise engaging in election related activity.
Signage: Not permitted on church property.

<b>Precinct #45 - Ellis</b>
<b>Ellis Park, 3541 Old Mocksville Rd., Salisbury</b>
Buffer Zone: 50 ft. from entrance; marked with cones, signs, and/or tape.
Campaigning area: Outside of 50' buffer zone. Tents and/or tables must never block traffic, fire lanes, entrances, or sidewalks, and are to avoid blocking parking areas. Handicap parking must never be blocked. Campaigning supplies must not be left unattended and may not be left at the precincts overnight.
Signage: Outside of 50' buffer zone.
