INSTRUCTIONS

- Schedule (A)** List total of all farm equipment owned by you in the appropriate year of acquisition. Grain bins are considered personal property and should be included on Schedule (A). Cost must include invoice cost, trade-in allowance, freight, installation costs, and sales tax. No depreciated cost will be accepted, as equipment will be depreciated by the year of acquisition.
- Schedule (A-1)** Report Additions and Disposals.
- Schedule (B)** Complete if you are farming leased land or are leasing to others to farm.
- Schedule (B-1)** List any improvements to real estate.
- Schedule (C)** **All leased farm equipment in possession of taxpayer on January 1, of current year must be reported.** The full name and address of the owner, type of equipment, make and model, selling price, date of lease, and rent must be given.

Your tax listing must be postmarked no later than January 31, to avoid penalty for late listing. An extension of April 15 may be granted (for good cause) provided a written request is filed with this office no later than the ending date of regular listing period. If extension is denied you will be notified. Only the date affixed by the U.S. Postal Service will be accepted as the date of listing. NO EXTENSION CAN BE GRANTED BEYOND APRIL 15.

Any individual who willfully makes and subscribes an abstract listing required by this Subchapter II of Chapter 105 of the North Carolina General Statutes which he does not believe to be true and correct as to every material matter shall be guilty of a Class 2 misdemeanor (Punishable by imprisonment up to 60 days).
